Course Description - The L-380 Training Experience will provide junior leaders with a set of tools and techniques to build and maintain cohesive crews or teams. It is designed to make an emotional and lasting impact on individuals beginning roles as leaders.

Class size maximum – 30

Course Intent – Guiding principles for achieving a lasting impact for students include;

- Enhancing the students understanding of the human dimension when leading others in dynamic work environments.
- Utilizing experiential training techniques that will engage students in ways that challenge them to perform under realistic and high-stress situations.
- Motivating students to examine their role as a leader and their strengths and weaknesses as a leader.

Target Group – Small work unit leaders. Personnel working to become qualified as Strike Team Leaders or Unit leaders within wildfire programs.

Prerequisite (s) – Students for this class should have:

- Satisfactorily completed pre-course work.
- Demonstrated leadership experience (demonstrated communication skills) (all risk or interagency, as determined by agency)
